# **Recreation Director Updates:**

Jessica Reynolds: The pool is looking great. We are struggling with the vacuum, it is old and it is not working well. We are looking at another one and they are about \$5500. The mulch was replaced at Critterville, and Tony came through to help get the material. The mulch is non-splintering and costed about \$3000. We have new swings and other items for Critterville. Tony Cordle: What are we doing with the old stuff? We may be able to use it at other places. Group discussion about the equipment.

Jessica Reynolds: We were able to get some additional paint and we were able to get 55 new chairs. It looks great. We have a great life guard staff this year and it is going awesome. We do have a mermaid event and we have the windows painted. It is \$10 a child, and we will have 5 mermaids. We have mermaid tails, and the kids will actually be swimming with them. We are also going to do a swimming with a super hero. Working on finishing up the budget year as well.

Tony Cordle: Are we still holding on the flag pole? We have the money for it. It has been a year out, so we need to follow-up with the town.

Jessica Reynolds: The stone over at Critterville looks awesome for the extended parking area. It was a huge help for the tournaments there.

Frances Meadows: It added so much parking for that and was great. Mark installed them, and we have some left over.

### Miscellaneous Updates:

Jessica Reynolds: We would use a couple of days here during the week, and Saturdays. Lisa Cordle: We will be finished before mid-August. We prefer to play at Critterville if we can. We can look at starting July 16<sup>th</sup> and go 4 weeks.

Rocky Hill: I make a motion to approve Lisa Cordle to have the 8U softball league during these times, and all team registration money goes to the Recreation park (\$150 per team). Corey Whited seconded the motion. No further comments. Motion carries 7/0.
